THE REASON IS A MYSTERY

And the Police Have no Theory—
He Was Going to Mineral,
Kansas.

Viet Caminolo, an Italian who came to this city yesterday from Wilberton, threw himself under the engine of a southbound Katy freight train opposite the section house yesterday afternoon at 5:20 o'clock and was horribly mangled, dying instantly. His neck was broken at the base. The fatal injury was a fracture of the neck, the left side of the neck was cut. The right hand was cut off at the wrist and the forearm smashed into a pulpy mass. The right shoulder bone was broken while a hole entering the shoulder penetrated the lungs to the heart. A hole entered in the back of the skull on the right side which exposed the brain. His chin was cut into deeply and the lower mandible shattered. His throat was a gaping hole and there were other slight injuries.

The police are at a loss to know what the motive was for the Italian's suicide. He had on his person a ticket to Mineral, Kan., and about eighteen dollars. Papers on him showed he was a member of the I. O. O. F. The order at this place took the body under its care and it was removed to the Chamberlain mortuary establishment, where it will be kept until instruction or information about the dead man be obtained.

Caminolo was about thirty years of age and was a man of rather slender build.

ALL OTHERS ARE BUT VANITY.
 The Charleston News and Courier, published in the Atlantic coast country, having a swelling of the head vanquish itself meekly, forgetting that haughtiness goeth before a fall, in these well chosen words on these "twelve" truths about Charleston:

"The number of umbrellas annually stolen in Charleston is less than in any other American city. More matches are heavily made in Charleston than in any other earthly city. No American city is so free of thin and side-whiskered stationaries as is Charleston.

"There is no city in the world so superior to the cities of Georgia and Texas as is Charleston. In Charleston the daily professions from dining with spirits are many more than in any American city. In Charleston it is more difficult to begin and more difficult to end a flirtation than in any other American city. In Charleston a man seldom loses his temper or his watch. Charleston is more unlike Atlanta than any other city in the world.

"There is less unseemly haste in Charleston than in most cities. The proportion of Charleston's population supported by walking canes is smaller than that of other cities. Charleston has the only rooster in the world capable of murdering the sleep of two wards at the same time."

Well, since when all virtues over the cities of coast, plain and date? As if there were not others which have not umbrellas—and to spare. As to whether there are any divers asked or granted in McAlester, for example, well, consult the ticket. Considering plain cities—and this is one—this one is easily in the lead of so-called heavenly matches, which are daily made—and broken.

To be sure, there are no chin or side-whiskered stationaries in or about other cities—barring Indianapolis, of course—and in fact, this city has few respectable whiskers—the village goat excepted—or stationaries. Go elsewhere for the near-great, thou dostard, the plain citizen with the best, due not doubt to the fickleness of the climate and the consequent mercurial temperament of the sons of men.

In McAlester, at least, men neither lose their watches nor their heads—except, heinously, during elections—when each elector needs have about him a watchman and a policeman's club to keep him from his aid politics on straight. At all other times there is the gentle and even tranquillity of the Mary-lamb. On the matter of "unseemly" hate, the palm should neither be claimed by nor awarded to any other American village, but to McAlester. The motto of this city has

That proportion of other cities not supported by walking canes goes on, as a rule, and while this city has few canes—but innumerable chin-men—yet many first class men, as unusual and startling as this observation may appear to the average reader, are to be found in this city, who have not only no canes but no other visible means for support.

On roosters, the second ward takes all comers, and they have them of all types of value and feather. No Charleston cannot take all the honors, whether of bird or beast. McAlester is entitled to what she has, even if not the best. Let here herald her many advantages in the wide world.

A ROGUE'S TARIFF REFORM.
 That the straightforward attitude of Bryan and the democratic platform has forced Taft to take a new tack on some questions which his party refused to endorse in convention at Chicago is clear to all.

Among those belated attitudes which the republican aspirant has assumed may be mentioned the publicity of campaign contributions after the election. Mr. Taft also has written, "by its friends"—after the election.

The Nashville American, commenting on an editorial of the Philadelphia Record, has this to say on the heading of the republican nominee:

"Mr. Taft has announced that the names of contributors to the republican campaign fund will be published. This may be said to be a forced statement, the result of democratic announcement. Mr. Taft also says that if elected he will call an extra session of congress next March to revise the tariff. Another statement made as a result of the democratic platform. But this statement sounds strangely out of harmony with the strenuous republican objections to 'tinkering with the tariff and disturbing business interests.' It will cause the trusts and tariff beneficiaries no concern, however, for they well understand that the republican party will not seriously interfere with existing tariff schedules.

As the Philadelphia Record says: "Under republican rule there can be no reform of the tariff save in the interest of producers, while the democrats demand a revision in favor of the masses of American consumers. All the promises of tariff reform that are now wrung from the fears of the republican leaders are therefore worthless. The elements that control the republican party will never permit it to arrest the legalized means of despoiling the masses of the people. Tariff is manifestly in the grasp of these elements as so in his associate, Sherman. The democratic party alone deserves confidence in this momentous issue because it alone is free from the sinister influences to which the republican party has long succumbed."

"It has been the republican boast that the tariff should be revised by its friends." This means that there will be practically no revision. There will be a real, honest tariff reform until it is done by democrats. The tariff beneficiaries know this and they will vote for Taft. His announcement causes them to wink an "eye."

THE CHEROKEE DIVISION Will Be Shortened 16 Miles and Wagoner Will Be Terminal.

The Katy is preparing to take the steam shovel from Yale, Okla., on the Oklahoma division, to Wagoner to construct the new yards for the removal of the terminal from Muskogee to that place. It seems that there are a number of reasons that make it imperative for the Katy to make Wagoner the terminal instead of Muskogee, the principal one of which is the sixteen hour law. Under the present conditions the Katy can not keep the crews at Muskogee without the expense of paying the men while they are staying there idle. Another reason is, the road can not acquire additional land at Muskogee except by paying fabulous prices. Otherwise it is not to be had. Another reason is the supply of water. At Muskogee there has always been a shortage of water, while at Wagoner arrangements will be made to get an abundant supply from the Arkansas river, which is only three miles distant.

While the preparations are going on for the removal of the terminal, Muskogee is bustling and bustling, and declares that the town will ship no more freight over the Katy. The Katy has made all of the actual tests necessary in the matter of the conforming to the sixteen hour law, and finds that it can not comply with the law under the existing conditions with the terminals at Muskogee, and the matter of changing simply a matter of miles north, does not seem to be a matter of choice, simply a matter of compulsion.—Parsons (Kan.) 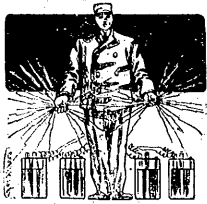
